CALGARY, Alberta, Canada. The Municipal District of Rocky View No. 44 (East Balzac) issued a notice today to all Developers/ Engineering Consultants & Contractors recommending the use of FireCaddy™ fire suppression systems as first response fire protection during construction.

The MD recently arranged a demonstration of the Fire Caddy with Mark Hayes, President of Just-in Case Fire Ltd. at the East Balzac Site. The purpose of the demonstration was to provide Rocky View Emergency Services and the Safety Codes Officer an opportunity to review and comment on FireCaddy™ systems being recommended to developers for use on their sites.

The Emergency Service commented that “the system is not a replacement or (reason) for any delay of notification through 911 for fire response to the facility” and that “proper housekeeping and hazard awareness will continue to be key components of any site’s fire preventing and emergency preparedness program.” It is the recommendation that a FireCaddy™ “must be brought to the site of the hazard, before any activity is started such as welding, to ensure that there is immediate access” to the system for first response to fire. “It is designed for the occupants’ use when a fire is in the initial stages, with no life safety issues.”
